

## **Service Agreement for BuyLeft (ShareRight Platform)**

This **Service Agreement** ("Agreement") is entered into between BuyLeft (referred to as "we," "us," or "our"), and the user (referred to as "you" or "your") who wishes to use the services provided by BuyLeft's sharing platform ("Platform"). This Agreement outlines the terms and conditions under which you may use the Platform and the associated services.

### **1. Definitions**

**1.1. Platform:** Refers to BuyLeft's online sharing platform, accessible through various websites and mobile applications.

**1.2. User:** Anyone who accesses and uses the Platform, including buyers, sellers, and other participants.

## 6. Disclaimer and Limitation of Liability

6.1. **No Warranty:** You acknowledge that your use of the Platform is at your own risk. The Platform is provided "as is," and we make no warranties regarding its uninterrupted or error-free operation or the accuracy of information provided by users.

### 6.2. Limitation of Liability

You expressly agree that, to the fullest extent permitted by applicable law, neither BuyLeft nor its affiliates, employees, directors, officers, agents, or representatives shall be liable for any direct, indirect, incidental, special, consequential, or punitive damages, or any loss of profits or revenues, business interruption, loss of business opportunities, or loss of data, arising from the use of or inability to use the services provided by BuyLeft, whether in contract, negligence, tort, equity, or otherwise. You acknowledge and agree that this limitation of liability is an essential basis of the bargain and reflects a reasonable allocation of risk.

## 7. Force Majeure

7.1. We shall not be liable for any disruptions to the Platform due to events beyond our reasonable control, including but not limited to natural disasters, internet failures, or government actions.

## 8. Notices

8.1. Legal notices will be sent to the email address in your profile. Notice shall be deemed given 24 hours after email is sent.

## 9. Governing Law and Jurisdiction

9.1. This Agreement is governed by the laws of Singapore. Disputes shall be resolved through amicable negotiations or, if necessary, through arbitration with the Hong Kong Arbitration Centre (HKIAC).

## 10. General Provisions

10.1. **Entire Agreement:** This Agreement constitutes the entire agreement between you and BuyLeft, superseding any prior agreements.

10.2. **Severance:** If any provision of this Agreement is held invalid, the remaining provisions shall remain valid.

10.3. **Headings:** Headings are for reference purposes only.

10.4. **Independent Contractor:** No agency, partnership, or employee-employer relationship is created.

10.5. **No Waiver:** Failure to exercise any rights under this Agreement does not constitute a waiver.

10.6. **Assignment:** BuyLeft may assign this Agreement to affiliates or successors.
